****The MOVER must notify the Cass County Sheriff's Department @ (402) 296-9370 and the Cass County Department of Roads @ (402) 296-9353 twenty-four hours prior to the move and after the move is completed.** If assistance is required by the Sheriff's Department it shall be the 'MOVERS' responsibility to contact that office and make appropriate arrangements.

General Provisions: This permit is granted with the understanding that:

1. The 'MOVER' assumes all liability and responsibility for all property damages or personal injuries, which may occur in consequence of this movement.
2. A 'CERTIFICATE OF INSURANCE' in the amount of \$500,000 aggregate coverage shall accompany this permit application.
3. The 'MOVER' shall comply with all laws of the State of Nebraska and all rules and regulations of Cass County Department of Roads, which have been herein, adopted relative to the use of the roads for movement of special vehicles or objects. This permit is issued only for roads directly under the jurisdiction of Cass County and in no way does this permit allow the 'MOVER' to cross over or upon the State Highway right-of-way.
4. This permit shall be carried in the vehicle to which it refers and shall be open to inspection by any police officer or authorized agent of Cass County Department of Roads.
5. Violation of any of the terms or conditions of this permit shall automatically revoke it and the penalty of the original limitations shall be applied.
6. 'MOVER' shall notify all utility companies as necessary.
7. It shall be the 'MOVERS' responsibility to see those obstacles such as signs be removed the day of said move and directly before the structure being moved. It is equally important that the signs be replaced directly after said structure has passed said obstacles.
8. It shall be the 'MOVERS' responsibility to see that the road remains in the same condition that it was in prior to the move on a daily basis.
9. If the construction activity causes excessive dust conditions (as determined by the Highway Superintendent) it will be the 'MOVERS' responsibility to resolve the problem as directed by the Highway Superintendent.
10. Cass County roads are considered public roads and shall remain open during any move, unless approved by the Highway Superintendent prior to the move.
