- 1.) Zoning- Language clarification on Section 4.11 and strikeout of AG Preservation Easements
 Jensen presented his Board of Commissioners Staff Report noting: On November 7, 2023 board members unanimously ordered change to Section 4.11 to allow for accessory structures on parcels more than 20 acres without the requirement of a primary residence. Stating on December 11, 2023 the Planning Commission recommended approval with a 5-0 vote that Section 4.11, include Exception "A" to not apply to AG, TA, and RA parcels more than 20 acres, accessory buildings in these districts are strictly for storage of agricultural equipment and livestock.

AG Preservation Easements strikeouts: the Planning Commission recommended with a 4-1 vote to strike out the following items: Section-5.07.01 – Residential Acreage Cluster Developments – the entire section; Section 5.08.01-Residential Acreage Development and Cluster Development – all of "A; Section 5.08.07-Residential Acreage Development – strike out Deed Restriction line in "A"; Section 5.12.5- strike entire section; Section 5.12.6 – amend "A" to eliminate Deed Restriction line.

2.) Zoning- Administrative Subdivision 5-acre lot in 17-11-10

Jensen presented his Board of Commissioners Staff Report noting: this is an Administrative Subdivision located in the NE ¼ of SEC 17-11-10, this is a 5-acre split on the south side of Waverly road in an 80-acre agriculturally zoned parcel. Stating on December 11, 2023 the Planning Commission recommended with a 5-0 vote to approve the Administrative Subdivision of a 5-acre lot in the NE ¼ of SEC 17-11-10.
